- c. All the original documents must be brought at the time of interview and must be submitted to the office at the time of the admission.
- d. Office timings of the college will be 12:30 pm to 4:30 pm
- 3. **College Fee Submission :** Candidates admitted to the college must deposit the required college fee at the respective Fee counter through following ways -
 - (a) Demand Draft/Pay Order of any Bank in Favor of "Principal, S. S. Jain Subodh Commerce and Arts College" payable at Jaipur.
 - (b) Deposit Cash in any e-mitra counter by challan obtained from college.
 - (c) Online fee submission through Net Banking/Debit Card/Credit Card by link given on College website www.subodhcomartscollege.com
- 4. After submitting the proof of fee deposition, the applicant will collect college fee receipt from fee counter.
- 5. The last date of submitting application form without late fee is 14th August 2020.
- 6. Incomplete application form and forms received after the last date will not be entertained.
- 7. No admission will be given to any student after the last date as declared by the state government.
- 8. The candidates appearing for supplementary examination can take provisional admission in the Part I before the last date of admission
- 9. Signature of parents is essential on the admission form.
- 10. Attested photocopies of following documents should be attached with the application form:
